

## ADVERTISEMENT FOR BIDS

### SOUTHEASTERN CUSD #337

Time and place of opening bids: Sealed proposals for the **Bowen Elementary School Boiler Asbestos Abatement**, Southeastern CUSD #337 in Bowen, Illinois, described herein will be received at the superintendent's office, PO Box 215, Augusta, Illinois until **1:30p.m.** on Tuesday, **July 9<sup>th</sup>, 2019**. A public bid opening will occur immediately after bids are due.

Description of work: Base Bid A work includes the abatement of asbestos containing materials and boiler removal associated with the existing steam boiler which serves the gymnasium and 3-story building. Base Bid B work includes the abatement of asbestos containing materials and boiler removal associated with the existing hot water boiler which serves the north area of the building.

Bidders can obtain Bidding Documents electronically from Klingner and Associates, 616 N. 24<sup>th</sup> St. Quincy, IL 62301.

Bids shall be accompanied by a Bid Bond in the sum of 5% of the **TOTAL BID** provided by Bidder. A certified check or bank draft, payable to the order of the **Southeastern CUSD #337** equal to this amount will be an acceptable Bid Bond.

Pursuant to Section 10-20.21 of the School Code, awards will be made to the lowest responsible bidder as reasonably determined by the Board of Education considering conformity with specifications, terms of delivery, quality and serviceability. In evaluating these factors, the Board will necessarily consider and compare (relative to the other bidders) the experience of the bidder on this type of project or similar projects, AND the performance history of the bidder regarding conformity with specifications, meeting terms of delivery and quality of work AND the performance history and ability of the bidder to complete the project on time, to service the product (including response time to service calls) and workmanship on the project. **THE OWNER IS NOT OBLIGATED TO ACCEPT THE LOWEST DOLLAR BID AND RESERVES THE RIGHT TO REJECT ANY AND ALL BIDS OR TO WAIVE ANY INFORMALITIES, IRREGULARITIES, TECHNICALITIES, OR DEFECTS IN ANY BID SHOULD THE BOARD DEEM IT IN THE BEST INTEREST OF THE SCHOOL DISTRICT TO DO SO.**

No bid may be withdrawn for a period of sixty (60) days subsequent to the specified time for receipt of bids.

Bidders are notified that not less than the prevailing wage rate as determined for Hancock County Illinois shall be paid to all workmen performing work under this contract. A copy of the prevailing wage schedule for Hancock County will be provided in the project manual. Contractor's and subcontractor's monthly payroll records will be required to be submitted to the Owner. This project is exempt from Illinois sales and use taxes.
